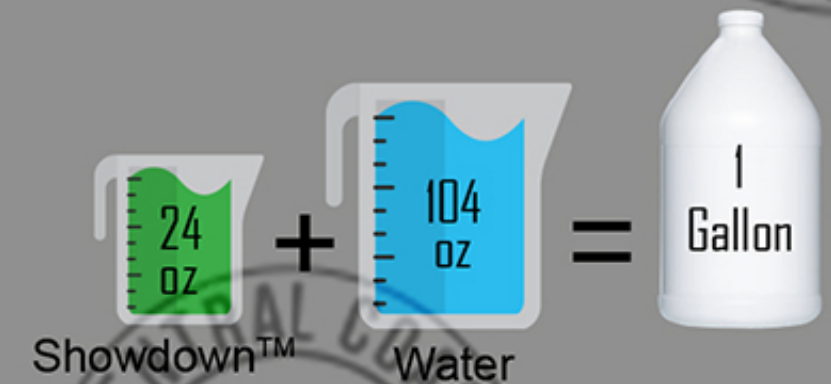

### How It Works

ShowDown™ goes to work by removing the plant's waxy layer and penetrating deep into the roots, completely preventing the plant from uptaking essential amino acids and nutrients.

### Directions For Mix

SHAKE Showdown™ REALLY WELL before measuring. Next, start with 24 oz. of Showdown™ concentrate and add 104 oz. of water to make 1 gallon of Ready To Use. More or less of the concentrate can be mixed based on weed size and weed type. Repeat application may be necessary.



### Directions for Use

Spraying may be done 8 hours prior to rain or irrigation. You will notice weeds browning in 1 to 2 days of application and complete kill in 5 to 10 days depending on temperature. Showdown™ should not harm higher order plants like trees, shrubs and vines when slight over spray contacts them, however some discoloration may be noticed.
